

WSVF Privacy Policy

This Privacy Policy sets out how YG Branding & Design Experts and UPM Raflatac, as the organizers of the Wine & Spirits Virtual Fair (hereinafter "WSVF", "our", "we" or "us"), collects and uses information provided by the attendees ("User" or "you") when fulfilling registration form and/or participate or attend the WSVF.

This WSVF Privacy Policy applies to the site of the WSVF and to the media platform used by the WSVF. This WSVF Privacy Policy does not apply to other web sites to which we link.

Collected information.

We may collect the following information:

- Personal information from Users in a variety of ways, including, but not limited to, when Users subscribe, participate or attend the WSVF, and in connection with other activities, services, features or resources we make available when realizing the WSVF. When subscribing to attend the WSVF, Users may be asked for, as appropriate, name, email address, mailing address, phone number, credit card information. We will collect personal identification information from Users only if they voluntarily submit such information to us. Users can always refuse to supply personally identification information, except that it may prevent them from attending the WSVF.
- Non-personal information about Users whenever they interact with the WSVF. Non-personal identification information may include, company data, human resource information, market information, etc. or information & personal data.
- Cookies and log files may be used to enhance User experience. A cookie is a small text file written to an individual's hard drive that contains the User ID. User's web browser places cookies on their hard drive for record-keeping purposes and sometimes to track information about them.

User may choose to set their web browser to refuse cookies, or to alert you when cookies at being sent. If they do so, note that some parts of the WSVF's website may not function properly. We use this information to:

- Process your request for attendance at the WSVF and verify your identity;
- Improve the quality of the WSVF;
- Improve security by protecting against fraud and abuse;
- Allow you to access the WSVF and accounts, and to service your account;
- Communicate with you about the WSVF;
- Provide you with personalized offers, updates and marketing from organizers and WSVF;
- Provide technical support to the attendance at the WSVF;
- Comply with applicable legal requirements and protect our legal rights and the legal rights of our users and other third parties;

- Conduct analytics and measurement to understand how the WSVF is used;
- Engage in other legitimate business activities as permitted by law; and
- Comply with your requests and to carry out any specific purposes for which we have obtained your consent.
